#### 4. Amy Broadhurst

The Chair directed the board to the report in the board papers. The Chair informed the board that Amy Broadhurst is a boxer who has previously competed for Ireland, but it also a British citizen with a British Passport and has reached out to GB Boxing to enquire about the possibility of competing for GB Boxing at the final qualifier and if successful the Olympic Games at 60kg with the following recent competitive record:

- 2022 Commonwealth Games – 60kg – Gold
- 2022 European Championships – 64kg – Gold
- 2022 World Championships – 64kg – Gold

The Chair emphasised the point that the of GB Boxing is to win Olympic medals. The Chair informed the board that all other relevant parties had approved the change of nationality from Ireland to Great Britain, including the Irish Athletic Boxing Association (IABA), the Olympic Federation of Ireland (OFI), the British Olympic Association (BOA) and the Paris Boxing Unit (PBU). Should the GB Boxing board agree to the change, were Amy Broadhurst to be selected and to qualify, then ratification would be required from the IOC Executive Board.

Following further discussion, each director voted on the proposal as recommended and all directors voted in favour of the change of nationality.
